Agenda: Discussions and Decisions on 10th BoG agenda and notes presented by The Principal, Government Engineering College, Sreekrishnapuram, Palakkad.

The meeting scheduled to start at 09:30 AM was delayed by 30 minutes due to the power failure in the campus. The meeting started at 10:00 AM with a welcome address by the chairman. The chairman accepted the leave request made by the members (1) Dr. P.P. Deepthi, Associate Professor, Dept. of ECE, NIT Calicut, (2) Smt. R.S. Pushpakumari (Ex-officio), Additional Secretary, Finance Dept., Kerala and (3) Dr. B.S. Manoj, Associate Professor, IIS1, Thiruvananthapuram, Kerala, over phone, expressing their inconvenience in attending the meeting. The Principal made a power point presentation highlighting the major developments in the college since the 9th BoG meeting. The Principal highlighted the readiness of faculty hostel and the student hostel. He projected the commendable improvement in the TEQIP-II activities since the 9th BoG. The Chairman had requested the Principal to take all steps to ensure the completion of syllabus, to improve the pass percentage of students.

RESOLVED, that all steps must be taken by the Principal and HoDs to ensure the completion of syllabus.

With this, the Principal, Government Engineering College, Palakkad submitted the 10th BoG agenda notes for discussion.

The BoG expressed its satisfaction over the development of TEQIP-II activities in the institution. The BoG appreciated the team work of nodal officers and the coordinators in the implementation of TEQIP-II activities in the institution. However, the BoG expressed its concern over the slow pace of activities resulting in lesser expenditures of the fund available and had urged the nodal officers to ensure the involvement of all faculties and staff to work towards the effective utilisation of fund and the completion of the project in time.

The BoG requested the Principal to form a technical committee and proceed with the procurement of 100 kVA DG Set. Principal to take actions in case of non-cooperation from the enneerned departments. RESOLVED, that the BoG reject the proposal to purchase of the two items ROBO LAB and Educational training kit on wireless sensor network by cancelling the approval for DG Set. FURTHER RESOLVED that, the BoG accept and approve the proposal for civil works: Electrical Maintenance (TEQIP-II/KL/KL1G16/96) using the balance amount available after the completion of civil packages planned.
17	B 10.15: Any other item with the permission of Chairman	The BoG noted the SPFU direction to utilize the interest amount. Further, the BoG after discussions with students had noted the shortage Desktop computers in CSE labs, affecting the research work of M Tech students. Again, the BoG noted the considerable delay in obtaining data of students and staff in the institution. Hence, a campus management software was suggested by the BoG for solving the problem. Hence, the BoG recommended the purchase of these items for the labs and institution utilizing the interest amount available with the institution. HoD CSE was requested to give the specifications for these items. RESOLVED that, the BoG approve the two packages proposed at an estimated cost of (1) Desktop PC (25 Nos): 12 Lakhs and (2) Campus Software Management: 6 Lakhs to purchase utilizing the interest amount available with the institution. 
