ADMISSION TO ENGINEERING/ARCHITECTURE/PHARMACY COURSES-2021
SECOND PHASE CENTRALISED ALLOTMENT PUBLISHED

The second phase allotment to Engineering, Architecture and Pharmacy Courses-2021 is published in the website www.cee.kerala.gov.in.

The details of allotment of a candidate such as **Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details**, etc. will be available on the Home page of the candidate as well as in the Allotment Memo. The candidates should take a printout of the allotment memo from the Home Page.

Candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **21.10.2021 to 25.10.2021, 4.00 pm**. The candidates who get a change in allotment other than that of the first allotment should pay the balance fee, if applicable, to be paid to Commissioner for Entrance Examinations through the above mentioned mode of payment within the prescribed date. The list of Post Offices having facility for fee payment is available in the website.

Candidates who got allotment (including those who have got allotment in the first phase and remitted fees) in Govt. Controlled/Private Self Financing colleges should join the course/college allotted as per the second phase allotment memo before **4 pm on 25.10.2021**. Candidates who have got allotment in Govt. Controlled/Private Self-financing college but unable to present themselves at the college physically due to Covid-19 or natural calamities following heavy rain should contact the Colleges concerned. Such candidates should participate in the admission process as instructed by the college authorities.

Candidates who have got allotment (including those who have got allotment in the first phase and remitted fees) in Government/Government Aided Colleges shall not join the respective colleges now. However they should complete the Online reporting through the website of the Commissioner for Entrance Examinations as per the instructions given. The detailed schedule regarding the admission of the candidates in the colleges will be notified later, if necessary.

The detailed schedule showing the date and time for joining to Engineering/Architecture/pharmacy courses is published in the website www.cee.kerala.gov.in. Candidates are required to visit the website of the colleges concerned for instructions if any, with regard to the admission.

Candidates who have an allotment can download the 'Data Sheet' containing the basic details of the candidates by clicking the menu item 'Data Sheet' available in the home page of the candidate. The printout of this Data Sheet along with the documents prescribed (as applicable) in the clause 11.7.1 of the Prospectus are to be produced before the college authorities at the time of admission.

Those candidates who do not remit the fee/balance fee (if applicable) and who do not join the course/colleges, either online or by appearing before the colleges allotted within the stipulated time will lose their allotment as well as all the existing higher options, if any, in the stream to which the allotment belongs.

The detailed notification regarding the 3rd phase allotment, if any, will be published later.
